Field Day

This will assist in promoting our event and reduce the call sign for our members that contest during field day. Some Club History (from 1990)

Our club has been around since the early 70's. Here are some highlights of a meeting from November 21st of 1990.

The meeting was called to order at 1940 hours by president Brian Burke N6VBM. After the flag salute, we had self-introductions. Bill KB6EII gave the treasurer's report: \$1333.49 in the general fund, and \$407.49 in the repeater fund. Secretary Jim KC6FKF read the minutes of the

previous meeting. Dick KA6JGP reported on nominations for officers for 1991: President Jerry Ducey WD6DYG, VP Hun McDowell KC6FKF, Secretary Glenn Miller N6GIW, Treasurer Bill Chamber KB6EII, Board of Directors Stan Spaeth WB6QFE and Ace Briggs W6CTS.

Jerry WD6DYG reported on a raffle prize for the next meeting. Jerry had accidentally misquoted that he was going to purchase a 220MHz radio, but that he should have said it was a Kenwood TM-231 two-meter radio. Comments from the members indicated that some people may not want a 2 meter or 220 radio, but maybe they would want a 440MHz radio. After a "healthy" discussion, it was decided that the club would purchase a \$400 gift certificate from Amateur Electronic Supply and let the winner purchase the equipment of their choice.

A discussion was held on where to hold the installation dinner. Options were "Henry's A Restaurant" at the Yucca Inn, or Sizzler. Sizzler does not allow large groups on weekends. The members decided to hold the dinner at Henry's.

The guest speaker was Ben Boswell from the Dept. of Public Safety in San Bernardino. Ben is a ham (KC6KSV) and is in charge of restoring the county RACES program. He spoke about that, and also about the new 800MHz radio system that the Sheriff is now using.

The meeting adjourned at 2119 hours.

Broadband Hamnet

Broadband Hamnet a.k.a. High Speed Multi-Media (HSMM) Mesh is a network of small and inexpensive radios that combine to provide a high speed data network to ham radio operators. This concept had some of its beginnings in the military where there was a need for fast deploying, redundant, and fault tolerant data networks. This network requires line of sight between stations. However, as long as you can see one station, you can access all of the other networked stations.

A common use of this network is to have a data network that is outside of the internet between Government Emergency Operations Centers (EOCs). These agencies are able to send files, emails, and chat messages between each other, even if the normal internet was not operational. This system can also be networked with RF packet stations to enable BBS mail and internet email to be sent to distant locations without the need for local (or even regional) internet. This system could easily have inexpensive file servers and webservers that would enable the information flow of whatever was deemed necessary by the users.

Imagine a survivor, in a city where a tornado has knocked out cell towers, who turns on their cell phone to find only one open wi-fi network that they have never seen before. When they click on this lone open network, they are greeted by an information page that is published and updated by the local EOC. There could also be a link that connects them to simple email page, that allows only a short and simple email to be sent out, an "I am ok" message perhaps. A different link could be a page that allows anonymous users to register, and then be enabled to post comments. These comments could allow friends and families to find each other, or for the EOC to keep tabs on developing intelligence. This is only a small example of how a Broadband Hamnet mesh network could be employed in a local community during a disaster.

There are a number of consumer radios that are available to be easily modified for ham only use. Common consumer radios are the Linksys WRT54GL or the Ubiquity Air Grid. These radios go through a simple process to have modified firmware installed that enables these radios to only operate on channels: 1-6. Coincidently, channels 1-6 fall within the 2.4 GHz Ham Band. By operating on these channels, a Ham operator is authorized to use higher power and higher gain antennas than are authorized to the unlicensed consumer who is limited to FCC part 15 rules. There are several radios that look similar, but are not suitable to be modified for Ham Operator use. Due to fine print in part 97 of the FCC rules, standard encryption for Hams is authorized above 50 MHz (along with some other requirements) as long as the encryption is not used to obscure the message and the encryption is only used to secure the network from intrusion. (http://www.broadband-

CALLSIGNS

Occasionally I have heard that there may be some confusion regarding ham radio callsigns. We currently have three license classes: Technician, General, and Extra Class. You are assigned a callsign according to your license class when you get your license. I have also read that the FCC will no longer mail out paper licenses. You can print out a copy at their web site, FCC.GOV.

If you are a Technician class, your will be assigned a random callsign called a two plus three. (Example: KK6ABC.) Once you have your assigned call, you can apply for a Vanity call. A Vanity call is any callsign that was not assigned to you randomly according to your location and license class. If a person with a Tech license wanted a different call, they could apply for another randomly assigned call, or ask for a specific call. A Technician or General class ham could ask for a call like mine, which is a one plus three type. (Example N6GIW). You might want to get a call with your initials in it. If your name was JOHN PAUL SMITH, you might check on the availability of a call such as W6JPS. (It doesn't have to be a 6th area call. You could ask for W1JPS.) The call must be available, and there are ways to check for call availability on the internet. Technician and General class hams are entitled to the same type of callsign. We no longer test for Advanced class, but there are people out there with Advanced class licenses. They usually have two plus two calls, such at KK6AZ. When you make Extra Class, you can enjoy the privileges of applying for callsigns like one plus two type (W6BA), or two plus one calls (WW6W). However, most of these calls have been taken, so good luck!

If you are a Technician and upgrade to General, you will not be given a new call unless you ask for one. When you upgrade to Extra Class, and you ask for a new callsign, you will be given a new two plus two callsign. An example would be AA6ZZ. One plus two callsigns are no longer available except through the vanity program.

Our club callsign, W6BA, belonged to Bill Adams. Bill was a famous contester and long-time resident of 29 Palms and member of the radio club. When Bill died, his family gave the club permission to apply for his callsign. I applied for the call and received it from the FCC. I am the trustee of the club callsign, and was allowed to apply for it because I have an Extra Class license. There is a club vanity callsign system run by the FCC that allows a club to apply for a call after a club member has died, but before the callsign has become available to the general ham radio population. The applicant's license class must match the type of callsign that is requested. A club can have only one club callsign.

My wife Charlotte has my father's call, K6EEF.
