FCC Speedily Dismisses Petitions to Alter Amateur Service Rules

Acting with near lightning speed, the FCC has dismissed two petitions for rule making calling for separate amendments to the Part 97 Amateur Service rules. Willison H. Gormly, WD0BCS, of Des Moines, New Mexico, filed both petitions on June 16, and the FCC turned them away on July 1. Gormly had requested that the FCC amend \$97.301(e) of the rules by dividing it into separate subparagraphs for technician and Novice class privileges. He had also asked the FCC to amend \$97.305(c) to authorize spread spectrum emissions in the 2 meter band.
